Our underwriters work hard to position themselves uppermost in the thoughts of brokers and clients seeking to place or renew

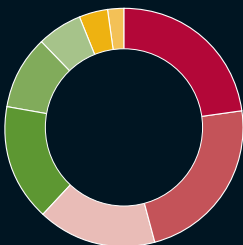
