OUR PORTFOLIO

Property

We write a property account for the whole of Europe, excluding the UK, on a treaty and facultative basis. We also write both on a catastrophe and risk excess of loss basis.

Our capacities for 2010 are €10m for any one catastrophe programme and €5m for any one risk programme. We write property on a facultative excess of loss basis, with a capacity of €25m for 2010.

Accident, Health and Life

Our accident, health and life business is a worldwide account, which provides protection for:

- Life
- Personal accident
- Disability
- Medical expenses
- Workers Compensation Act

We write the account on a catastrophe excess of loss business with a capacity of €30m.

Marine

We write marine hull and cargo on a treaty and facultative basis.

- Energy: treaty and facultative
- Casualty: treaty
- Financial Institutions: facultative
- Terrorism: treaty and facultative

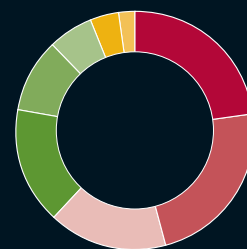
At the core of our business are Chaucer Syndicate 1084 and Nuclear Syndicate 1176, which together have an underwriting capacity of over £650m for 2009.
